

A Memorandum of Understanding for Academic Collaboration
By and Between
Shri Jankiraman College Jabalpur
&

SANCHI UNIVERSITY OF BUDDHIST-INDIC STUDIES, SANCHI, M.P.

In pursuit of excellence in scholarship, for the purpose of disseminating knowledge to the mutual benefit of Shri Jankiraman college Jabalpur Madhya Pradesh AND Sanchi University of Buddhist-Indic Studies, Sanchi, Raisen, Madhya Pradesh 464661 (henceforth referred to as SUBIS), a state university established by the Government of Madhya Pradesh under Sanchi University of Buddhist-Indic Studies Act, 2012. The parties (Shri Jankiraman & SUBIS) hereby sign a Memorandum of Understanding (MOU) on Academic Collaboration and exchange as follows:

1. Both Institutions agree to undertake, within the framework of regulations applying in each of the institutions, subject to availability of resources, the following:
 - a. Launching of Joint Research Activities, including, for this purpose, the Exchange of Faculty Members and Research Personnel,
 - b. Collaboration in various forms of Teacher Training,
 - c. Introduction of value added courses/ programs, add on courses directed towards skill enhancement,
 - d. Facilitate adequate exposure for Students by way of field trips/ visits,
 - e. Exchange of Academic and other Publications, and
 - f. Organization of Joint Conferences, Seminars and Academic Meetings.
2. The terms of and the necessary resources for such joint activities and exchange programmes shall be discussed and mutually agreed upon in writing by both institutions prior to the initiation of particular activity or programme.
3. The agreement shall take effect on the day which it is signed and shall continue until terminated by agreement between the parties. Any changes must be agreed to in writing by both parties. A minimum period of six months notice will be required from either party wishing to terminate or amend this agreement. In the event of termination the relevant parties will honor all commitments to students participating in the program.
4. Any issues that are not addressed or stipulated in this MOU shall be discussed and resolved through negotiation in good faith and such resolution will be incorporated as written amendments to the MOU by mutual agreement between the two Parties.
5. No disputes are foreseen in the implementation of this MOU. The two Parties, however, agree that if any dispute arises between them, efforts will be made to settle the same as amicably as possible. If the dispute remains unsettled, it will be referred for resolution bilaterally to Vice-Chancellor, Sanchi University of Buddhist-Indic Studies, Sanchi, Raisen, Madhya Pradesh. The decisions so arrived at shall be final and binding on the parties to this MoU.
6. This agreement shall take the effect when signed by both the parties.

This MOU has been executed in two originals, one of which has been retained by the each party. IN WITNESS WHEREOF, the parties have executed this MOU and represent that they approve, accept and agree to terms contained herein.
