UNDERTAKING BY HOSTEL RESIDENTS

1. That I shall obey in word and spirit the rules and regulations of the Hostel and any amendments thereof.
2. I shall at all times maintain the discipline and decorum of the Hostel.
3. I shall preserve, tend and safeguard the property of the hostel, and shall not knowingly or otherwise destroy, damage, or deface Hostel property.
4. I shall keep my room and the common grounds of the hostel clean and unsoiled at all times and shall make it available for inspection as and when required.
5. I understand that ragging is strictly prohibited under provisions of UGC Regulations, 2009 and is an offence. Any involvement shall lead to my summary termination from the University.
6. I understand that use of any addictive substance like tobacco, alcohol, narcotic or habit forming drugs, etc., is strictly prohibited in the hostel / University Campus under NDPS Act, 1985 (as amended from time to time). I shall be liable for any disciplinary action for indulgence in such activity, viz., smoking, consumption of alcoholic drinks or any other intoxicating substance in hostel / University premises and found under its influence at any point of time / place during my studies in the University.
7. I shall maintain my valuables in my own custody. The hostel management/University administration is not responsible for any loss or damage.
8. I agree that no entry or exit shall be made by me from 07:00 PM to 07:00 AM in Hostel, unless specific permission is taken.

9. I understand that prior permission has to be obtained from the competent authority to visit outside campus for bonafide purpose; I shall be solely responsible for my safety and protection during my departure and return to University Campus /hostel. In case I leave the University Campus /hostel without prior permission, University administration/ Hostel Management can initiate the disciplinary action against me and University administration/ Hostel Management authorities are not responsible for my safety.
10. In the event, when I take a leave (with permission) to visit hometown or other places, I shall be solely responsible for my safety and protection during my departure and return to the University Campus /hostel.
11. In the event of my parents/guardians or relatives are visiting me, I shall inform the Warden in advance and access/contact with them, meeting in the hostel or going out for local visit shall be with the consent of the Warden (Written permission).
12. I understand that no friends or outsiders are allowed in the hostel premises. Also, men cannot go to the women's hostel or vice versa if not otherwise stipulated and any such visit shall be seen as a serious misconduct, inviting penalty.
13. I shall play a proactive role as a student and suggestions / feedback for improvement or any concerns about aspects of hostel life shall be brought to the notice of hostel in-charge/Assistant Hostel/Warden immediately.
14. I shall strive to play a proactive role in keeping gender amity and maintain cordial & harmonious relations with all, group, individual and authorities on the campus. I understand that the University observes a non-negotiable stand with regard to issues of caste, creed and communal harmony.
15. I understand that my involvement in any unacceptable behavior under the code of conduct and above and any violation of hostel rules shall lead to my immediate expulsion from the hostel/University.
16. I shall not change my allotted room without permission from the authority.
17. I shall vacate my allotted room during summer vacation or any other vacation. I shall request to stay only after taking permission from Warden/HOD, if he/she is involved any course work / project work / University work/ Hostel work.
18. I understand that I am not permitted to keep and use any motorized vehicle inside as well as outside the campus of University without prior permission.
19. I shall agree not to cook, not to use any heavy Electric gadgets, Heater, Microwave Oven, ironing cloths inside the room. I shall not cause any damages whatsoever, including defacing the property of the Hostel and I understand that I shall be liable for penalties and punishments for doing so. I shall not damage any furniture or fixtures of the room allotted to me and will agree to pay for the damage if any.
20. I am physically and medically fit to stay in the Hostel. I also declare that every information about my being medically / psychologically unfit in any degree or manner has been brought to the information of the University authority at the time of applying for Hostel accommodation. I shall not hold the University responsible for any consequence which will be result of my non-disclosure and will not request for refund of Hostel fees.

21. I shall not use external speakers along with my computers, if any, and cause disturbance to others in the Hostel.
22. I shall not use social websites for spreading misinformation about others and nor shall I tarnish the image of others. I shall not indulge in any activity leading to cyber crime.
23. I shall ensure that all dues, including any fines or penalties that may have been imposed against me, are paid in time to the University.
24. I shall strictly observe and abide by the code of conduct the Hostel.
